UDATA Corp., known as UDATA_{net}, provides Dialup Internet access, Hi-Speed Wireless Internet access, Redundant Dedicated Business Hi-Speed Internet access, and Webmail.

UDATA_{net} provides access to it's network by AT&T all-digital, fiber-optic networks.

The monthly charge for Hi-speed Wireless is \$30.00 for a single computer and \$15.00 for each additional computer. The billing is monthly with payment by cash, check, money order, credit card (*Master Card, Visa & Discover*) or debit card.

The monthly charge for Dialup is \$11.95 for 30* hours per month, \$15.95 for 40* hours per month, \$19.95 for unlimited hours per month, or Email only at \$4.95 per month. The billing is monthly with payment by cash, check, money order, credit card (*Master Card, Visa & Discover*) or debit card. First time users to UDATA_{net} pay for 1st month and receive 2nd month Free.

*Accounts with counted hours will be charged at a rate of \$2.00 per hour if the total hours of 30 or 40 hours is exceeded. Your account will continue to work, it will not be shut down if you reach 30 or 40 hours. It is your responsibility to keep watch of your hours. There is a time clock on UDATA_{net}'s home page just for this purpose. You can check the status of your account at any time. Enter username and password and the total time used in your current billing period will be displayed. Make sure you are looking at your account.

Accounts are charged on the setup day of the month for each account and payment is due within 15 days of that date. Accounts may be suspended if payment is not received within 30 days of the due date. Accounts are charged and paid in advance on the current month in use. If an account is suspended for nonpayment, there will be a \$10.00 reactivation fee. A \$2.00 late fee will be added to all accounts which are not paid by the **15-day due date which is printed on each invoice under Balance Due.**

Accounts will be immediately terminated if a check for payment is returned from bank for NSF. A \$20.00 service fee will be charged to that account.

Change of billing plan will take effect on NEXT billing day.

Your time roll-over date and your billing date is the same day of the month on which your account is setup. (example: *setup date: 4/13/08, billing date: 13th. of every month, time roll-over date: 13th of every month*)

Cancel internet account:

The internet account is month-to-month. If you want to cancel the agreement, simply notify UDATA_{net} in writing, Email or phone call at least 10 days before the end of the month and your account will be canceled as of the end of the current month. Any current charges will still be due.
